



My name is Orville E. Johnson and I have been a practicing physician since 1894 and I have practiced in Linthrop since 1895. I am a graduate of Harvard Medical School of the class of 1894. I have known the claimant for 25 years and I have been treating him off and on for almost that entire period. For the past three years I have been seeing him at frequent intervals. Since Oct. 8, 1929, he has been under my constant care.

The claimant, Ir. Rouillard, at the present time is suffering from vertigo, extreme weakness, severe coughing, poor eyesight, and marked general debility. He is unable to dress himself, spends a considerable of the time in bed, has poor appetite and has to be helped from the bed to his chair. Fentally he is Clear. Diagnosis is general arterio-sclerosis and semile debility. The attacks of vertigo are due to cerebral arterio-sclerosis. In the past three or four years he has had numerous small cerebral hemorrhages with resultant disability and dizziness

- Q. Will you tell me, doctor, to just what extent Mr. Mouillard is helpless so far as his physical needs are concerned?
- A. He cannot feed himself, dress himself, has to be helped about the house, incontinence of urine and feeces. He can sit up in his chair, his hearing is good, he can read headlines in the paper, that is, coarse print. He can take a few steps but he has to be helped wherever he goes around the house. He requires the constant presence of an attendant by that I mean some adult member of the family must be present to take care of Ir. Rouillard all the time. I am the daughter of the claimant and I have always lived with my father and mother with the exception of two winters when I left someone here to look out for them. My husband works in Boston but comes home to this house every night. I work for the Audobon Society part times when I am able to get some one to stay home and take care of my father and mether. Then I work I have my sister-in-law come to take care of the folks. I only work one or two days a week - in fact anytime that I can get away. Somebody must be here all the time to take care of my arents. My nicce Elsie also lives here in this house with us. I am 36 years of age will be 37 years of age in March. My husband is an electrician and works in boston for the Pullman Company.

- Q. Will you tell me, Frs. Edwards, just what your father can do for him self, if anything, in fact, I would like to have you tell me just the condition of your father since he had the first paralytic stroke back in 1922.
- A. By father had very good health up to the time he had the first stroke October 12, 1922. He was in bed for along time after that stroke I don't remember just how long. Ever since then he has been more or less dependent upon some one. Last spring around about April or May he had a minor shoke and was in bed about a week. Following the second stroke and since then he has not been able to get about by himself at all. My father went out twice for an automobile ride between the time he had his second stroke and this last one but he had to be carried to the automobile by my brother. The last time he has been out of the house was just before Labor Day and that was the occasion on which my brother carried him from the house and back into the house. By father was most certainly not able to go up or down them stairs alone.

My father took his last shock at 2 o'clock on the morning of October 6, 1929. No, I am wrong about that date. It was on Friday, the 4th of October. I remember the date now becasue it was the date on which I was going to the office to work and I was working only on Mondays and Fridays and this happened on a Friday because I remember that I called up the office and told them that I couldn't go to the office that day because my father had a shock. At two o'clock on the morning of the fourth we called in Dr. Johnson and he told us that he was not certain that father was going to live. I asked him if it would be advisable for me to send for my brother in New Hampshire right away and he told me to wait until 11 o'clock that morning and he would inform me if there was any immediate danger of my father not living. About noon of that day father recovered his speech. Since the last stroke he has been in worse shape than he was before. It was three weeks before we was able to get him out of bed and after that we were able to get him to his chair near the window and he has been either in that chair near the window or in bed.

- Q. Where is the claimant's bedroom?
- A. It is that room just to the left of where you are sitting.

  (The distance from the bedroom of the claimant and the chair in which he is now sitting is about 25 feet. whm).

My father is not able to go alone from his bed to his chair. Either I or someone else has to help him because we are afraid that he will stumble if we let him do it by himself.

- Q. What is the condition of your father's enesight.
- A. Not very good. He can see to read the headlines in the paper and that is all.
- Q. Can your father dress and undress himself?
- A. No. He is absolutely helpless in that respect. My mother used to dress and undress him up until she had a shock on New Years Day but she is not able to do that herself now so I have to do it. He has no control of his bowel movements and unless we watch him and get him to the toilet he will soil his underclothing. At night time we always have to use a night pan for his wants along that line.

My fathers mental condition is very good for a man of his age. His hearing is fairly good and he has a very good recollection of dates. His

physical condition is what is bad - his mental condition as I said before is remarkable good for a man of his age.

- Q. Can your father take care of his wants so far as feeding himself is concerned.
- A. By father's diet consists almost entirely on soft foods and juices. Someone has to be present all the time while he is eating. We have to do everything but chew his food for him. If we leave him along he spills his milk or whatever he is drinking all over himself. He doesn't eat any meat at all except chicken. He can't cut any of his food at all. That has to be done for him. He can use a fork to raise the food to his mouth, and that is about all.
- Q. Can your father do anything at all for himself?
- A. Well, I will go over his daily routine for you if you want. By father wears practically all of his clothes to bed and in addition to this he wears a bathrobe. He has a hot water bottle at his feet summer and winter and it is beyond me how he can stand it sometimes in the summer. Everyday about 10 or 11 o'clock we, that is, my mother and myself and most of the time myself, put on his trousers for him. Dressing him consists only of putting on his trousers and taking the bathrobe which he has been wearing and putting on another bathrobe. Before the last shock father used to be able to get to the table for breakfast but since the last shock he cats breakfast in bed.
- Q. Does he eat breakfast in bed by himself?
- A. No. He has to be fed because if he wasn't he would spill everything all over himself and the bed. His breakfast consists of coffee and porridge.

After father is dressed either I or someone else (mother when she is able) takes him over to that chair by the window where you see him now and he stays there all day except we sometimes move him over near the radio where he sits and listens to the radio.

- Q. Now you say that you dress your father in the morning, help him eat his breakfast and assist him to his chair near the window and you do this every day. Didn't you say that you are employed part time?
- A. I have never gone to work at any time before noon since my mother had a shock last New Year's day. I can't leave either my father or my mother alone at any time. I only work two days a week and that is only in the after-

-5120

noon. At lunch time we take his food to him in the chair. Sometimes at night we bring him to the table to eat. Yes, most of the time we bring him to the table to eat out once in a while he prefers to eat sitting in the chair and then we bring the food to him. We help him to bed around about 7:30 or 8:30.

- Q. What other ailments does your father suffer with besides paralysis?
- A. My father has had kidney trouble as far back as I can recember and he suffers with sick headaches. He also has dizzy spells and during those spells his mind is clouded. Dr. Emerson in Weymouth back in 1923 told my father that he had a growth on his kidneys but that was never verified and I don't know just how much faith to place in Dr. Emerson's statement. Dr. Johnson never told us anything about that.
- Will you tell me about the marital history of your father?
- A. Hy father has been married twice. He was married on Jan. 29, 1867. He had four children by his first wife three living and one dead. His second marriage took place on Nov. 26, 1874. His first wife died in April, 1874. There was eleven children in all in my family, that is, I have had three sisters and seven brothers.
- Q. You know, Mrs. Edwards, that a soldier to be entitled to the \$90.00 rate must be totally helpless or blind. Do you think your father is totally helpless?
- $\Lambda_{\bullet}$  Yes, I think my father is totally helpless and I think he is entitled to the increase of pension

In furtherance of claim for increase of pension under section 1, act of July 3, 1926, filed October 23, 1929 for George Rouillard, Pension No. 1086154. I feel that as a United States Citizen and a Voter, I have a privilege of making a few statements relative to the notice just received rejecting my father's claim.

Hust what does total helplessness mean in the eyes of the law? To me it would seem that when my father is on his deathbed which is liable to be at any time, he already having suffered from three shocks, that should I immediately get in touch with your Department, you probably would send an investigator at a cost of his travel and maintenance while in this vicinity and if my father is really dying you would probably grant the increase to be paid to him and by the time it would have gone through the necessary formalities he would be in his grave and the money would go back to the apparently needy U. S. Treasury. As it is why isn't my father allowed this small sum of \$18.00 a month extra to provide he and his wife with the few necessities and comforts they need. Can you tell me how it can possibly be arranged for a man, helpless as he is (apparently the Doctor and myself who took oath to his helplessness are liars) with a wife who suffered a shock recently and has been in a most pitiable condition since your investigator came here and through his long grind of inquiry to me and my father and the thought that she would have to go through the same thing, can live in comfort on even \$90.00 a month and yet you expect it done on \$72.00. Why doctor's calls twice a week (should be more but it can't be done) and medicines total \$40.00 a month. Figure it out yourself if such can be done through the needless red tape of your Department.

This rejection will not only prove a disappointment to my father but it will, I fear, cause more than that as he feels that he has done his bit and it hurts him severely to think that an Old Civil War Veteran should receive such treatment and in behalf of my father I feel that I am right in making statements against your unjust decision.

Referring to your communication of February 8th, reference "MBAB", regarding accrued pension check for \$66.67, deceased pensioner George Rouillard, No. 1695429, I am enclosing herewith "Application for Reimbursement" in favor of my sister, Mrs. Ruth E. Edwards.

I might add herewith that my father was attended from date of his first shock, October 12, 1922, until June, 1930, by his wife, Emma R. Rouillard, and she was assisted in this by Mrs. Edwards. In June, 1930, my mother, Mrs. Emma R. Rouillard, was stricken with a shock and my sister then had full care of George Rouillard, together with stricken mother. Mrs. Edwards cared for my father until his death, and my mother until her death in October.

In November accrued pension check (JS-#1086154-(#2098)--dated November 1st, 1931 (widow subdivision W. C. 1695429)--for \$66.67 was marked for my mother, then deceased. Had my mother lived she would have received this check and would have given it to my sister, as she always felt that my sister did not receive near what she should for the faithful care and attention given her parents.
